No resident, customer, job applicant, employee or Councillor will receive less favourable treatment on the grounds of gender, race, colour, creed, nationality, ethnic or national origin, religion or belief, age, transgender status, physical or mental disability, sexual orientation, marital status or pregnancy nor will be disadvantaged by any condition which cannot be justified.

The Council will ensure that all decisions on participation, recruitment, selection, training, promotion and career development are based on abilities, merits, and objective job-related criteria.

All staff and Councillors are required to behave in a non-discriminatory manner and to create a culture in which people can feel confident of being treated with fairness, dignity and tolerance.

### Implementation:

The Chairman and all members of the Council have responsibility for the effective implementation of this policy. All members are expected to create the equality environment, which is its objective.

In order to implement this policy, the Council will:

- Communicate the policy to members by issuing a copy of this document to all its members.
- Where appropriate, the Council will endeavour through appropriate training to ensure that it will not consciously, or unconsciously discriminate
- Incorporate specific and appropriate duties in respect of implementing the equal opportunities policy into roles and responsibilities of the Council.
- Ensure that adequate resources are made available to fulfil the objectives of the policy.

### Monitoring and Review:

The council will establish appropriate monitoring systems to assist the effective implementation of its equal opportunities policy. The effectiveness of the equal opportunities policy will be reviewed annually and remedial action will be taken as necessary.

### Notes to the Policy:

In relevant circumstances, acts of bullying, harassment, victimisation and unlawful discrimination will be dealt with as misconduct under the Council's grievance and/or disciplinary procedures and appropriate action will be taken.

Particularly serious complaints may amount to gross misconduct and lead to dismissal without notice in the case of staff. Sexual harassment may amount to both an employment rights/Code of Conduct infringement and may also be a criminal matter, such as in the case of the allegation of sexual assault. Harassment under the Protection from Harassment Act 1997 – which is not limited to circumstances where harassment relates to a protected characteristic – is a criminal offence.

The Council has a Complaints Procedure. Use of the Council's Complaints and/or disciplinary procedures does not affect an employee's right to make a claim to an employment tribunal within three months of the alleged discrimination.
